CAPABILITY STATEMENT

1.0 About UMAP

Founded in 2003, the University of Missouri Assistance Program (UMAP) was first registered in Kenya as an International Non-Governmental Organization (INGO) under the country's NGOs Co-ordination Act. UMAP expanded its services in Africa on June 17, 2013 with registration in Ghana as an international NGO under the Ghana Companies Code 1963 as a Company limited by Guarantee.

UMAP was originally established to provide administrative and logistical management support to technical advisors working on the implementation of USAID activities under the Southern Sudan Agriculture Revitalization Project. However, the UMAP portfolio has since expanded to include operation as an international development logistics management and consulting company.

UMAP provides access to a wide range of logistical support and development consulting expertise in Africa through a combination of an extensive database of technical assistance expertise and an established network of travel and hospitality systems. As a result, UMAP can provide technical and administrative assistance within a specified budget to development partners, governments, businesses, civil society groups and communities to efficiently assist in the timely achievement of organizational objectives. UMAP also has the capacity to manage the implementation of development assistance projects throughout the African continent.

2.0 Core Competencies

UMAP assists clients to achieve their stated objectives by offering the following capabilities:

- i. <u>Legal Status</u> UMAP is legally registered as an INGO in Ghana with the capability to work anywhere on the African continent.
- ii. <u>Financial and Administrative Systems</u> UMAP has extensive expertise and knowledge of the policy, procedures and requirements necessary for working with USAID and USDA to ensure provision of sound financial and administrative systems to clients. UMAP is highly efficient in procuring goods and services that strictly abide by these established donor procurement procedures. UMAP is a good steward of donor funding with over 5 years of experience managing accounts in both the United States Dollar and the currency of the country of project execution. The accounts are well maintained with a consistent cash-flow to support activities and produce the necessary financial reports. UMAP conducts personal audits on an annual basis.
- iii. Management of Short- and Long Term Consultants/Employees UMAP has substantial management experience and capabilities in sourcing and hiring competent administrative and technical staff as well as short/long term consultants. Key services include: drawing employment, consultancy and/or service contracts; maintaining payroll; and ensuring compliance of all government statutory requirements on withholding taxes.
- iv. <u>Meeting and Conference Planning</u> As a result of our vast network, UMAP is able to facilitate and organize international/national conferences, e.g. booking venues, flights, transport, accommodation, payments of per-diems, etc. and manage other logistical requirements for international and local clients.
- v. <u>Logistics Management</u> UMAP has established exceptional relationships with hotels, tour companies, travel agents and courier firms to meet any logistical need. As a result, UMAP is able to open service and credit accounts to ensure continuous operation. We are therefore able to handle all travel needs: air-travel, ground and processing of travel documents efficiently.

The services provided included accommodation facilities for 20 persons to 150 persons, travel arrangements including ticketing, arrival and departure pickups and drop-offs to and from airports, meals and snacks (Tea/Coffee breaks and buffet lunches), Conference venues/equipment such LCD Projectors/Laptops, PA systems, Translation booth/equipment and payment of per diems. All conferences/meetings were organised using U. S. Department of State approved rates. The services of UMAP-Ghana have been used to cover Consultancy costs for USAID/USDA activities on the African continent.

iv. Development Program/Project design and implementation (2011-2016)

UMAP collaborated with the Ministry of Agriculture to design a CDN \$15M program to reorient agriculture education in Ghana titled Technical Education Development for Modernised Agriculture in Ghana (TEDMAG). UMAP will provide management expertise in implementing the program being executed by a consortium of universities (University of Saskatchewan and University of Missouri) from 2017-2021

Additionally, UMAP-Ghana provides clients with dedicated staff who assists in the planning and executions of clients' activities.
